OVERVIEW

Standss is excited to announce the release of SendGuard Version 5. This is a major new release and contains new features, improvements, and bug fixes.

Users of previous versions will need to contact their account manager at Standss (or emails us at <u>sales@standss.com</u>) to upgrade and get their new license information.

The following sections have more information on what's new, what's fixed and updating/deployment.

WHAT'S NEW

Better Logging and Reporting

User actions loggings are now logged in the new standard (JSON) which can be used in Reporting tools such as Power BI. We have sample reports available as well for Power BI.

If you still want to continue using SendGuard version 4, user actions that are logged in the reporting tool, will be converted into the new JSON Standard through a transformer.

Send Confirm, SendRules and DLP now Supports Linked Files (OneDrive)

Able to show Linked files attached to emails on SendConfirm prompt. Able to notify users that Linked files were not scanned when DLP and SendRules are executed due to app limitations.

Improved and Simplified Settings and Customization

Settings are being rearranged for ease of use. Customization of messages has more options now added to it.

SendRules ability to execute Before and After SendConfirm

Configure SendRules to prompt before SendConfirm prompt or After SendConfirm prompt depending on the scenarios

SendRules: Can control text on confirmation dialog buttons

You can customize **OK** and **Cancel** buttons with the text you want to.

Custom Scripts: New Functions

New functions were added according to our client's requirements. Contact <u>support@standss.com</u> for additional details.

SendRules: Separation of Send Rules registry settings

Before all rules were stored inside one registry settings. Now each rule has its own registry settings under the following registry hive: *Computer*|*HKEY_CURRENT_USER*|*Software*|*VB* and *VBA Program Settings*|*addins4office*|*SendGuard*|*v5*|*SendRules*

This allows the admins to manage the send rules settings easily.

SendRules: New condition check for attachments

A new condition check is added to SendRules in regards to Attachments. SendRules now has the ability to check the combined attachment size in an email. If it is greater then the X number of MB set in the rule, it will prompt the user.

SendRules: New Templates

There are 6 additional templates added to SendRules default templates. These templates are related to HIPAA (The Health Insurance Portability and Accountability Act), Irish PPS Number, UK Health Identification number, UK National Insurance Number and US Standard Health Identification Card Number.

DLP: UI update to Add, delete and Enable /Disable

You can easily Add, Edit and Delete DLP rules. Also, Admins can now enable and disable the DLP rules.

DLP: Separation of DLP rules registry settings

Before all rules were stored inside one registry settings. Now each rule has its own registry settings under the following registry hive: Computer\HKEY_CURRENT_USER\Software\VB and VBA Program Settings\addins4office\SendGuard\v5\DLPRules

This allows the admins to manage the send rules settings easily.

DLP: Export and Import Rules

Ability to now Export DLP rules to text file (.txt) as well as Import DLP Rules from text file into the app.

DLP: New Templates

There are 2 additional templates added to DLP default templates. These templates are related to HIPAA (The Health Insurance Portability and Accountability Act). Existing templates have been renamed and organized in Ascending order.
